RESOLUTION AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN

WHEREAS, the Monmouth County Division of Tourism desires to advertise on New Jersey Advance Media print and online outlets in order to bring awareness of Monmouth County as a travel destination; and

WHEREAS, more than 8.6 million people visited Monmouth County in 2018, spending over \$2.5 billion dollars; and

WHEREAS, the Division of Tourism desires to continue promoting the region as a viable vacation destination; and

WHEREAS, the Division of Tourism obtained a proposal from New Jersey Advance Media for a 9-month advertising campaign, at the total cost of Nineteen Thousand (\$19,000.00) Dollars.

NOW, THEREFORE, BE IT RESOLVED by the Board of Chosen Freeholders of the County of Monmouth that the County is hereby authorized to enter into an agreement with New Jersey Advance Media for a 9-month advertising campaign in the amount of Nineteen Thousand (\$19,000.00) Dollars.

BE IT FURTHER RESOLVED that the Freeholder Director, or his designee, and the Clerk of the Board are hereby authorized to execute any documents necessary to effectuate the full intent and purpose of this resolution.

BE IT FURTHER RESOLVED that this resolution is subject to the filing of a certification(s) by the Chief Financial

Officer, stating that funds are available in the 2020 budget, in the following line item and amount:
